



## SITE COOKIE POLICY

### INTRODUCTION

This page is a section of the privacy policy available on the website and specifically describes the use of cookies by the owner.

### INFORMATION ON COOKIES

Cookies are text files containing minimal information sent to your browser and stored on your computer every time you visit a website. With each link, Cookies send the information to the reference site.

They are used to improve functionality of the site, to enable the user to easily navigate between pages, remember preferences and to guarantee the user an optimal browsing experience.

### COOKIES TYPOLOGY

#### *Technical cookies*

This type of cookie is strictly necessary for some sections of the site to function properly. Cookie technology used by the owner can be divided into:

- ▶ **Session:** which are destroyed each time the browser is closed;
- ▶ **Persistent:** which are not destroyed when the browser is closed but remain until a pre-set expiry date.

These cookies are needed to view the site correctly and for the technical services, so they will always be used and sent unless the user changes the settings in their browser (invalidating page display for the site).

**The site currently uses only technical session cookies.**

#### *Analytics cookies*

These cookies are used to collect information on use of the site.

They collect anonymous data on user activities and how they arrived at the site. Analytics cookies are sent from the site itself or from domains of third parties.

**This site does not use analytics cookies.**

These cookies do not require a user's prior consent to be installed and used.

#### *Analytics cookies for third-party services*

These cookies are used to gather **anonymous information** on **use of the site** including pages visited, dwell time, origins of the traffic, geographic origin, age, gender and interest for the purposes of marketing campaigns. These cookies are sent from third party domains external to the site.

**This site does not use analytics cookies.**

#### *Profiling cookies*

These cookies are needed to create user profiles to send advertising messages in line with preferences expressed by the user in the site pages.

**This site does not use profiling cookies.**

#### *Cookies to integrate products and features of third-party software*

This type of cookie integrates features developed by third parties within the pages of the site such as icons and preferences expressed in social networks to share site contents or to use third-party software services (such as software to generate maps and software that offers additional services). These cookies are sent from third party and partner site domains that offer their functionality between the pages of the site. In this case the site owner acts only as an intermediary technician between the user and these sites.

**This site does not use cookies to integrate products and features of third-party software.**
